## INLAND REVENUE

From a business perspective, no doubt at the front of concerns for many. If your ability to make payments of any tax type (PAYE/GST/Provisional tax) is compromised by Covid-19 issues IRD are waiving penalties and interest, upon application after the full instalments have been paid. Satisfactory arrangements will still need to be made to pay amount outstanding over an acceptable timeframe.

- Monday $30^{\text {th }}$ August

## WAGE SUPPORT SUBSIDY

If your business cannot operate because of Alert Level 4 restrictions or you will lose revenue, you can apply for the COVID-19 Wage Subsidy scheme to help keep paying your staff.
Businesses and self-employed people must expect a $40 \%$ drop in revenue to be eligible to receive the wage subsidy. The wage subsidy is paid in a 2 week lump sum. You can get:

- $\$ 600$ per week for each full-time employee
- $\quad \$ 359$ per week for each part-time employee

Businesses anywhere in New Zealand can apply for the Wage Subsidy Scheme if they are eligible. Details as to eligibility criteria, in particular period of drop in revenue against which the $40 \%$ will be assessed are still to be made available. We expect to know more details when released on Friday.
As an employer you must pass on the full wage subsidy to your employee. If the wage subsidy is more than your employee's pay, you can continue to pay them at their normal rate.
If your business has to physically close but your employees can work from home, and you are not eligible for the Wage Subsidy Scheme, you need to keep paying them their usual salary or wages.
Applications for the August 2021 Wage Subsidy will open on Friday 20 August 2021 at 9am and will be open for 2 weeks. You need to apply through Work and Income. COVID-19 Wage Subsidy August 2021 - Work and Income

## RESURGENCE SUPPORT PAYMENT

The COVID-19 Resurgence Support Payment helps to cover wages and fixed costs for businesses who have been directly affected when there is an increase to Alert Level 2 or higher for a week or more.
To be eligible, your business must have experienced at least a 30\% drop in revenue or a 30\% decline in capital-raising ability over a 7-day period, due to an increase in Alert Levels.

You can receive $\$ 1,500$ per business plus $\$ 400$ per full-time employee (FTE), up to 50 FTE. The maximum payment is \$21,500.
If you're a sole trader, you can receive a payment of up to $\$ 1,900$.
Applications for the COVID-19 Resurgence Support Payment will open at 8am on 24 August 2021. You need to apply through Inland Revenue. COVID-19 Resurgence Support Payment (RSP) (ird.govt.nz)
You can apply for both the COVID-19 Resurgence Support Payment and the COVID-19 Wage Subsidy Scheme if you meet all the eligible criteria.

## OTHER SUPPORT AVAILABLE

## Leave Support Scheme

The Leave Support Scheme is available for employers to help pay workers who can't work from home and meet certain health criteria - for example, they have COVID-19 or are defined as a 'close contact' who has been told to self-isolate for 14 days. COVID-19 Leave Support Scheme - Work and Income

## Short-Term Absence Payment

The Short-Term Absence Payment is to help businesses keep paying eligible workers who can't work from home, and need to miss work to stay home while waiting for a COVID-19 test result (in line with public health guidance). COVID19 Short-Term Absence Payment - Work and Income
